

Dave and I joined the Z Club of San Diego in its inaugural year, 1991. He had his bright yellow, special edition Zap Z paint job '77 280Z, the same car he still proudly owned. Dave was a mainstay of the club serving as events coordinator 6 straight years, '93 – '98. He supervised registration at ZCON '94 held here in San Diego. He took the original club logo and had window stickers made for our car windows.

Car shows were his passion for awhile, and he had plenty of trophies to show for his effort. He participated in most of the club outings and runs. He took the Z America Relay leg to Phoenix, and attended the ZCON's held in Denver, Albuquerque, Los Angeles (stepping in to rescue their registration table.) His Zap Z was visible on the Death Valley, Hearst Castle, Black Hawk Museum and Idyllwild runs. He knew everyone and always kidded around with my wife

SCCA Road Rally "Rose Petals and Gas Petals" Saturday, February 13th, 2021

The San Diego Region SCCA is hosting it's first Road Rally of 2021 on Saturday February 13th!

What is a Road Rally you may ask? They're held on public roads, with a score being awarded based on correct arrival time at checkpoints, along a route that will take you through some of the best back country roads San Diego has to offer.

The **start location** will be the Walmart Supercenter located at 13487 Camino Canada, El Cajon, before heading east into the back roads of San Diego County. The exact route will be shared shortly before the event.

The rally is expected to cover about 70 miles, on *fun-to-drive* country roads following legal limits and should be completed in about 2 hours.

You'll need a street legal car, a driver and a navigator. The entry fee is \$25 per car and only the driver needs an SCCA membership (weekend memberships are available online through registration).
